F.C. Barcelona Soccer Camp – Participant Agreement

By signing below, you agree to the following terms and conditions: Transworld Soccer Inc., a Florida corporation (“we” or “us”) provides the FCB Soccer Camps described in the accompanying brochure. These terms and conditions apply to the FCB Soccer Camp named on the Guest Reservation and Payment Form (the “FCB Soccer Camp”) and the program for this FCB Soccer Camp.

Reservations: A \$350.00 payment per participant (except when otherwise noted in writing by us) and a completed Reservation Form (“Reservation Form”) are required with this Participant Agreement to reserve space for FCB Soccer Camp. All prices are in U.S. Dollars. Except as expressly stated in the brochure, you are solely responsible for any FCB Soccer Camp-related costs that you incur.

Client Cancellation & Refund Policy: If you choose to cancel your reservation, we must receive written notice of said cancellation either via certified mail, overnight courier, or e-mail sent to info@transworldsoccer.com (with confirmation of receipt thereof from us), and you shall be subject to the following cancellation fee schedule: If we receive written notice 40 to 30 days prior to the FCB Soccer Camp start date, you shall incur a cancellation fee equal to 50% of the payment price for the FCB Soccer Camp. If we receive written notice 30 days or fewer prior to the FCB Soccer Camp start date, or if you are a no-show, you shall incur a cancellation fee equal to 100% of the payment price for the FCB Soccer Camp.

Cancellation or Substitution: We may cancel any FCB Soccer Camp at any time for any reason, including without limitation if we deem the number of participants signed up for a given FCB Soccer Camp to be insufficient to operate such FCB Soccer Camp. We will make commercially reasonable efforts to keep the schedule as it has been published; however, the final schedule may vary due to factors beyond our control. We may in our sole discretion substitute services or goods of similar quality for any service or good stated in the schedule. If the FCB Soccer Camp is cancelled, our liability is limited to a full refund of your deposits and FCB Soccer Camp Price, and we will not be liable for any other costs, damages, or refunds of any kind for any loss, delay, inconvenience, disappointment, or expense whatsoever in such circumstances. If for reasons beyond our control, a FCB Soccer Camp in progress must be interrupted or cancelled, we will in good faith consider refunding a portion of the FCB Soccer Camp Price depending on our actual costs incurred compared to the FCB Soccer Camp as originally contemplated.

Certification of Participant’s Health; Responsibility to Inform Operator of Disabilities or Pregnancy: By signing below and/or tendering any portion of the FCB Soccer Camp Price to us, you certify that you do not have any condition or disability that would create a hazard for you or others participating in the FCB Soccer Camp. You agree to inform us via certified mail or e-mail sent to info@transworldsoccer.com (with confirmation of receipt thereof from us) at the time you tender your first payment of the FCB Soccer Camp Fee (or at such later time when you become aware of such a condition) of any existing physical or mental illness, disability, pregnancy or any other condition for which you may require medical attention or special accommodation during the FCB Soccer Camp. We make no guarantee to be able to accommodate you for such condition during the FCB Soccer Camp, and we make no representations or warranties regarding special accommodations or handicap accessibility on the FCB Soccer Camp.

Athletics Release: You hereby acknowledge that playing or practicing soccer is a potentially hazardous activity. You agree that you are voluntarily entering and assuming all risks associated with participating in those activities, including but not limited to falls, contacts with other participants, the effects of weather including heat and or humidity, and the conditions of the training grounds and facilities, all risks being understood and appreciated by you. Having read this waiver, and knowing these facts, and in consideration of Transworld Soccer’s acceptance of this application, you hereby waive and release the Transworld Soccer Inc. and its representatives from all claims and liabilities of any kind arising out of your participation in soccer playing, practicing, or training.

Responsibility/Liabilities: We act only in the capacity of agent for providing services or goods in connection with the FCB Soccer Camp (the Suppliers”), camp operators, and providers of entertainment. We assume no responsibility for any personal injury, property damage, or other loss, accident, delay, inconvenience, or irregularity which may be occasioned either by reason (1) any act or omission of any of the Suppliers (2) any matter beyond our exclusive control including but not limited to a delay or cancellation of a flight that causes you to miss any portion of the FCB Soccer Camp. We have no special knowledge regarding the financial condition of the Suppliers, unsafe conditions, health hazards, weather hazards, or climate extremes at the camp locations. You are also responsible for respecting the authority and following the directions of the FCB Soccer Camp guide during a FCB Soccer Camp. We may exclude you from participating in all or any part of the FCB Soccer Camp if, in our sole discretion, your condition or behavior renders you unfit for the FCB Soccer Camp or unfit for continuation once the FCB Soccer Camp has begun. Unfitness may include, without limitation, any behavior that, regardless of its cause, is inappropriate or offensive or interferes with the delivery of FCB Soccer Camp services, or may constitute a hazard or embarrassment. In such case, our liability shall be strictly limited to a refund of the recoverable cost of any unused portion of the FCB Soccer Camp. Should you decide not to participate in certain parts of the FCB Soccer Camp or use certain goods included in the FCB Soccer Camp, no refunds will be made for those unused parts of the FCB Soccer Camp or goods. You agree to indemnify and hold us harmless from and against any costs, damages, losses, or liabilities arising out of your actions or omissions.

General: Any dispute related to the FCB Soccer Camp shall be governed by Florida law without regard to conflict of laws principles. The federal or state courts in Dade County, Florida shall be the exclusive forum for any lawsuit related to the FCB Soccer Camp, and you consent to the personal jurisdiction by said courts. You agree to present any claims against us within 30 days after the FCB Soccer Camp ends and to file within one year of the incident, and you acknowledge that this expressly limits the applicable statute of limitations to one year. You agree to grant us (and third parties with whom we may engage in joint marketing) a worldwide, royalty-free, fully paid up license to use your photographic, video, or digital likeness solely for our promotional and/or commercial purposes. Facsimile transmission of any signed document shall be deemed delivery of an original. At our request, you shall promptly provide an original document as well. If there are any conflicts between this Participant Agreement, the Reservation Form, and the Itinerary, this Participant Agreement shall apply.
